In a Works Cited page, the header should be centered. It should start on a new page, be six spaces from the top, and be numbered consecutively. In other words, if your paper is eight pages long, the Works Cited page will be page nine. The heading needs to have a double space below it.

In MLA style, the Works Cited page appears at the end of your paper and gives full details of every source that you cited in the text. Like the rest of an MLA format paper, the Works Cited should be left-aligned and double-spaced with 1-inch margins. The only exceptions to this rule are personal communications with the author such as e-mails, conversations, and letters which need only be cited in text. Likewise, every item on the references page must correspond to an in-text citation somewhere in your work. Do not include works that you do not cite in the body of your paper.

When needed, to cite a source you found in another source, cite the original author and year, followed by "as cited in" the secondary author last name and year. For example: According to Smith (2017, as cited in Brown, 2020) students need faculty and staff support to succeed. More Examples:

The citation information in the body of the paper itself is called the "in-text citation." The most obvious time to use it in the text is when you use a quote from a source directly or refer to it by title or author. Generally, you need to list the writer's last name and page number enclosed within parentheses straight after the quote.
